This basic staple of Texas real estate law serves to transfer title to the grantee, and contains a full warranty of title, whereby the grantor warrants to the grantee that the title to the property is free and clear of any other claims. Obviously, such a deed, containing broad warranties of title, provides the best protection for the grantee.
